



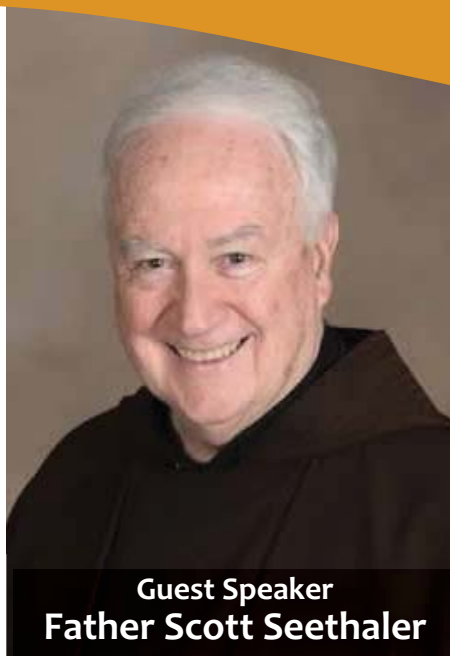

## Falmouth, Jamaica

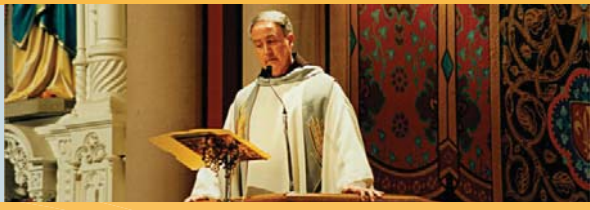
